Invitation for bid for trusteeship assignments

1. Introduction

- i) A detailed strategy/plan of action for reaching out to the respective Lenders/Borrowers in the transfer of assignments;
- ii) Provide regular updates on the progress made in acquiring the trusteeship business relinquished by UTI IAS;
- iii) Provide suitable consideration for acquiring the trusteeship business of UTI IAS; and
- iv) The appointed Trustee Company will be evaluated by the Board of Directors at its sole discretion.

5. Eligibility

- i) Bidders should have experience in the trusteeship business; and
- ii) Certify and undertake that the bidders would keep UTI IAS informed of any conflict of interest that may arise during the period of your appointment.

6. Submission of proposal

7. Submission of Bid (after due diligence)

- i) The financial bid will be for the UTI IAS assignments, as a whole and not for individual companies constituting the UTI IAS holding; any break-up of bid

amount company-wise will disqualify the bid. The bidder is required to quote a fee in INR for the transaction covering all the assignments.

- ii) The amount quoted by the bidder should be inclusive of all the applicable taxes, cess, duties, etc.
- iii) Based on the proposal/bids received in terms of this Request for Expression of Interest and its own assessment and evaluation, UTI IAS will finalise the appointment of Successor Trustee Company. UTI IAS reserves the sole right to accept or reject any or all proposals thus received, irrespective of the bid amount and without assigning any reasons thereof.
- iv) Bidders should submit their respective bid by 5.00 p.m. on 16/04/2018 of completion of the diligence at the address given in para 6(i). The diligence has to be completed by 12/04/2018 from the date of execution of the relevant documents including Non-Disclosure Agreement in the format as prescribed by UTI IAS.
